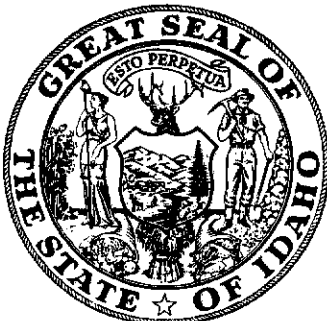

THE UNDERSIGNED, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is Curb Appeal, Inc.

SECOND: The period of its duration is perpetual.

THIRD: The purpose for which this corporation is formed shall be the transaction of any all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have the authority to issue is 5000 shares with no par value.

FIFTH: Provision for the regulation of the internal affairs of the corporation are such as may be provided by the By-laws of the corporation, by agreement of the stockholders, and the provisions of the Idaho Business Corporation Act.

SIXTH: The address of the initial registered office of the corporation is 1985 N. Aronmink, Ada County, Meridian, Idaho, and the name of its initial registered agent at such address is Ronald L. Shaw.

SEVENTH: The number of directors constituting the board of directors of the corporation is two, and the names and addresses of the persons who shall serve as directors




