## ARTICLES OF INCORPORATION 9 08

### COOPER LANDSCAPES, INC.

The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such Corporation:

FIRST: The name of the corporation is Cooper Landscapes, Inc.

SECOND: The period of the corporation's duration, subject to dissolution in the manner provided by law, is perpetual.

THIRD: The purposes for which the corporation is organized are: (1) the maintenance, repair and improvement of commercial, industrial and residential property, and (2) the transaction of any and all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is one thousand (1,000) shares of common stock, without par value.
