ARTICLES OF INCORPORATION

of

INDIAN VALLEY FIRE & RESCUE SQUAD, INC.

Pursuant to the provisions of Section 326(c), Title 30 of the Idaho Code (Idaho Business Corporation Act), the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

STATEMENT PURSUANT TO IDAHO CODE 30-327:

The following amendments of the Articles of Incorporation were adopted by all the members of the corporation pursuant to notice and special meeting of the members for that purpose as provided in and pursuant to the procedure authorized by Section 30-326(c) Idaho Code.

- 1. The present name of the corporation is Indian Valley Fire and Rescue Squad, Inc.: and
- 2. This amendment alters Article V of the original Articles of Incorporation, by adding language to qualify this corporation as a non-profit organization.

1-mmt: Articles Of Amendment

That Article V of the Articles of Incorporation of this Corporation shall be amended by adding the following:

- 6. This organization is organized exclusively for charitable purposes within the meaning of section 501(c)(3) of the Internal Revenue code.
- 7. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue law) or (b) by a corporation contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code of 1986 (or corresponding provision of any future United States Internal Revenue law).
- 8. Upon the dissolution of this corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code (or corresponding section of any future tax code), or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed by the Court of Common Pleas of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
