ARTICLES OF AMENDMENT

OF

SUN VALLEY SPECIALIZED OUTDOOR CENTER, INC.

- I. The name of the corporation is Sun Valley Specialized Outdoor Center, Inc.
- II. Article II of the Articles of Incorporation is hereby amended to read as follows: "This corporation is organized exclusively for religious, charitable, scientific, literary or educational purposes within the meaning of Section 501(c)(3) of the Internal This corporation shall exercise only such powers Revenue Code. as are in furtherance of the exempt purposes of organizations set forth in such section of the Internal Revenue Code. withstanding any other provision of these Articles, The corporation shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code. property of this non-profit corporation is irrevocably dedicated to charitable purposes and upon the winding up and dissolution of this corporation, after paying or adequately providing for the debts and obligations of the organization, the remaining assets shall be distributed to a non-profit fund, foundation or corporation which has established its tax exempt status under Section 501(c)(3) of the Internal Revenue Code."

III. The corporation does not currently have any members, and there-
fore, the above Amendment was adopted by a majority of the
Directors of the corporation at a special meeting of the Board
of Directors held on April 11, 1983.
