That we, the undersigned, being natural persons of full age and citizenship of the United States and of the State of Idaho, in order to form a corporation for the purposes hereinafter stated pursuant to the statutes of the State of Idaho, do hereby certify as follows:

I

That the name of the corporation is McCUISTION'S BULK HAUL, INC.

II

The purpose for which said corporation is formed is to acquire and own real estate and personal property, to engage in the hauling of milk and other commodities, to purchase and own trucks and tanks of all kinds and nature, together with any and all allied businesses in connection with the hauling operation.
