ARTICLES OF INCORPORATION  
OF  
PROFESSIONAL MOTOR SPORTS, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is Professional Motor Sports, Inc.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are:

1. To conduct, promote and operate motor vehicle and motorcycle races and racing.

2. The transaction of any or all other lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 200 shares, all of one class with a par value of \$50.00 each share.

FIFTH: The address of the initial registered office of the corporation is Route #4, Rupert, Idaho 83350 and the name of its initial registered agent at such address is Dan Copeland.
