WE, THE UNDERSIGNED, BILL LUKE, CHAIRMAN AND DONNA WEAST, SECRETARY OF THE BOISE VALLEY BAPTIST CHURCH, A CORPORATION, DO HEREBY CERTIFY THAT ON THE 20TH DAY OF JULY, 1983, AT 7:30 P.M., A SPECIAL MEETING OF THE MEMBERS OF SAID CHURCH CORPORATION WAS HELD IN THE SAID CHURCH, IN EAGLE, COUNTY OF ADA, STATE OF IDAHO, PURSUART TO DUE AND REGULAR NOTICE TO EACH MEMBER OF SAID CHURCH:
