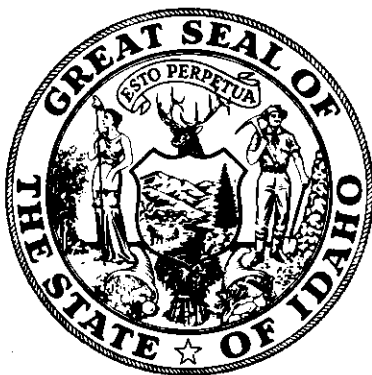

**CERTIFICATE FOR CHANGING THE NAME OF
BOISE VALLEY BAPTIST CHURCH**

WE, THE UNDERSIGNED, BILL LUKE, CHAIRMAN AND DONNA WEAST, SECRETARY OF THE BOISE VALLEY BAPTIST CHURCH, A CORPORATION, DO HEREBY CERTIFY THAT ON THE 20TH DAY OF JULY, 1983, AT 7:30 P.M., A SPECIAL MEETING OF THE MEMBERS OF SAID CHURCH CORPORATION WAS HELD IN THE SAID CHURCH, IN EAGLE, COUNTY OF ADA, STATE OF IDAHO, PURSUANT TO DUE AND REGULAR NOTICE TO EACH MEMBER OF SAID CHURCH;

THAT AT SAID MEETING MORE THAN TWO-THIRDS OF THE MEMBERS OF SAID CHURCH CORPORATION WERE PRESENT;

THAT SAID MEETING WAS CALLED FOR THE PURPOSE OF CHANGING THE NAME OF SAID CORPORATION;

"RESOLVED THAT THE CHAIRMAN AND SECRETARY OF SAID CHURCH CORPORATION BE, AND THEY ARE HEREBY AUTHORIZED TO EXECUTE AND FILE WITH THE SECRETARY OF STATE OF THE STATE OF IDAHO THE PROPER CERTIFICATE SHOWING THE NAME CHANGE.

THAT SAID PROCEEDINGS WERE HAD AND TAKEN UNDER THE LAWS OF CORPORATIONS OF THE STATE OF IDAHO;

THAT THE BOISE VALLEY BAPTIST CHURCH WAS DULY INCORPORATED UNDER AND BY VIRTUE OF THE LAWS OF THE STATE OF IDAHO.

WE FURTHER CERTIFY THAT WE ARE THE CHAIRMAN AND SECRETARY, RESPECTIVELY OF SAID CHURCH CORPORATION, AND THAT WE PRESIDED AS CHAIRMAN AND SECRETARY, RESPECTIVELY, OF SAID MEETING.
