

It is hereby certified that:

FIRST: The name of the corporation (hereinafter referred to as the "Corporation") is TRANSFEREE CORPORATION, a corporation organized pursuant to the provisions of the General Corporation Law of State of Delaware on the 7th day of April, 1982.

SECOND: Article FIRST of the Certificate of Incorporation, relating to the name of the Corporation, is hereby amended by striking out Article FIRST thereof in its entirety and by substituting in lieu of said Article a new Article FIRST to read as follows:
