That the undersigned, being a natural person of legal age and duly licensed to practice nursing in the State of Idaho and acting as incorporator of a corporation, pursuant to the Professional Service Corporation Act of the State of Idaho, Idaho Code Title 30, Chapter 13, does hereby certify as follows:

ARTICLE I.

The name of this corporation is JANET P. GARLAND, P.C.

ARTICLE II.

The purpose or purposes for which the corporation is organized are, without limitation of the powers granted by the Law of the State of Idaho, as follows:

- a. To practice and engage in the practice of nursing and to do such other things as are incidental, proper, or necessary in the operation of said practice.
- b. To engage in activities that are necessary, suitable, or convenient for the accomplishment of the above stated purposes, or which are incidental thereto or connected therewith.
- c. The practice of nursing shall be carried on only through officers, employees, and agents who are duly licensed or otherwise legally authorized to render professional nursing services within the State of Idaho, together with assistance from such persons as are needed to assist one who is licensed to practice nursing.

ARTICLE III.

This corporation shall have a perpetual existence.

ARTICLE IV.

The total number of shares which the corporation is authorized to issue is ten thousand (10,000). The aggregate par value of such shares is -0- and the par value of each share is -0-.




