## ARTICLES OF INCORPORATION

OF

MT. BORAH CONFECTIONS, INC.

KNOW ALL MEN BY THESE PRESENTS, that we, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, and to that end do hereby adopt Articles of Incorporation and do hereby CERTIFY in writing as follows:

I.

That the name of the corporation shall be MT. BORAH CONFECTIONS, INC.

II.

That the purposes for which said corporation is to be formed are as follows:

To make, manufacture, merchandise, sell, offer for sale, franchise and distribute at wholesale and retail, foods and foodstuffs, ice cream, ice milk and associated novelty items, sundries, fancy goods, goods, wares and merchandise of every kind and nature now or hereafter customarily sold in this type of business or similar businesses or otherwise, and to generally deal in ice cream, ice milk and associated novelty items and allied products of every kind and nature, or to contract for the performance of such purposes.

To purchase, acquire, through the issuance of its own capital stock or otherwise, own, hold, lease, either as lessor, lessee, sell, exchange, subdivide, mortgage, deeds in trust, improve, develop, construct, maintain, equip, operate and generally deal in any and all lands, improved and unimproved, and buildings of any kind, and the products and avails thereof, and any and all other property of any and every kind or description, real, personal, and mixed, wheresoever situated more particularly to manufacture, construct and

have manufactured or constructed any and all machinery necessary or required for the production of the above named products.

To do all and everything necessary, suitable, and proper for the accomplishment of any of the purposes or the attainment of any of the objects or the furtherance of any of the powers hereinbefore set forth, either alone or in association with other corporations, firms, or individuals, and to do every other act or acts, thing or things incidental or appurtenant to or growing out of or connected with the aforesaid objects or purposes or any part or parts thereof, provided the same be not inconsistent with the laws which this corporation is organized, as fully as natural persons and to use and apply surplus earnings or accumulative profits to the purchase or acquisition of its own capital stock, from time to time, and to such extent and in such manner, and upon such terms as its board of directors shall determine.

The purposes specified herein shall be construed both as purposes and powers and shall be in no wise limited or restricted by reference to, or inference from, the terms of any other clause in this or any other article, but the purposes and powers specified in each of the clauses herein shall be regarded as independent purposes and powers, and the enumeration of specific purposes and powers shall not be construed to limit or restrict in any manner the meaning of general terms of the general powers of the corporation; nor shall expression of one thing be deemed to exclude another, although it be of like nature not expressed.

III.

That the principal office, and place where the principal business of said corporation is to be transacted is 120 N. 5th St., in the City of Boise, County of Ada, State of Idaho.

IV.

That this corporation shall have a perpetual existence.

That the number of directors of said corporation shall be at least six(6).

### VI.

That the total authorized amount of capital stock of said corporation shall be \$750,000.00 divided into 75,000 shares of common stock of the par value of \$10.00 each.
