

**CERTIFICATE : INCORPORATION OF CHURCH.**

**KNOW ALL MEN BY THESE PRESENTS:-** That we, the undersigned, have this day voluntarily associated ourselves together for the purpose of incorporating under the laws of the State of Idaho, and in pursuance of the purposes for which we have been elected, as hereinafter set forth a religious corporation to be known as the Congregational Church of McCall, Idaho.

And we certify that the objects for which this corporation is formed are:- To establish a mission Church in the village of McCall, County of Boise, State of Idaho, and in connection therewith suitable and customary organizations, for the purpose of public worship and religious training, according to the rules and regulations of the Congregational Denomination, under the supervision of the General Conference of Congregational Churches and Ministers of Idaho, to take charge of the Church building, estate and property, and the affairs of the temporalities thereof.

That the principal place of business of said Corporation shall be the village of Mc Call, County of Boise, State of Idaho.

That the term of the incorporation shall be twenty years.

That the number of Trustees who shall have the management of its affairs, as aforesaid, shall be three and the names of the Trustees for the first year are:-

O. O. Barnes,	whose residence is	McCall, Idaho.
E. A. Cole,	"	"
C. W. Davidson,	"	"

That the said Trustees were duly elected at a meeting of the members of said Church duly convened and held at McCall, Idaho, for the purpose, among other things, of electing Trustees to take charge and management of its property, temporalities and affairs and to form this incorporation. That a majority were then and there present and voted at such election for the above named Trustees, as is more particularly set forth in the Certificate and verification by the officers who conducted the election, hereto annexed and made a part of these articles.

This is to certify that at a meeting of the members of the Congregational Church of McCall, Idaho, duly convened for the purpose hereinafter set forth, held at McCall, Idaho on the 19 day of April, 1916, a majority of said members being then and there present and voting at said election. The Pastor, Rev. A. R. Betz, was requested to preside and Mrs. J. N. Peterson, to act as Secretary, with which requests they respectfully complied.

The meeting then proceeded to the election of three Trustees, to take charge and management of the property, temporalities and affairs of the Congregational Church of McCall, Idaho, and instructed to form an incorporation of the organization under the laws of the State of Idaho, in furtherance of the object for which the Church is founded.

The following trustees were then duly elected, viz:-  
O. C. Barnes, E. A. Cole and C. W. Davidson, all residents of the village of McCall, Idaho, and vicinity, County of Boise, State of Idaho.
