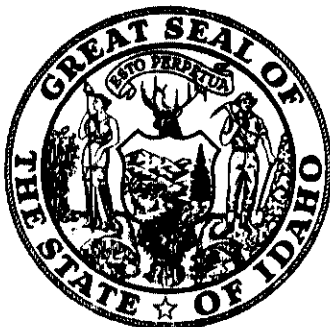
### CERTIFICATE OF AMENDMENT OF

ARTICLES OF AMENDMENT  
OF  
HIGH DESERT CONSTRUCTION, INC.

The undersigned person of the age of twenty-one years or more, as incorporator of a corporation (hereinafter referred to as "Corporation") under the provisions of the Idaho Business Corporation Act (hereinafter referred to as the "Act"), adopt the following Articles of Amendment.

ARTICLE I

The name of the Corporation is High Desert Construction, Inc.

ARTICLE II

The Corporation was organized on the 2nd day of November, 1993.

ARTICLE III

The Corporation, on the proposal of its sole incorporator, sets forth the proposed amendment:

Article VIII (8), Section 2 of said Corporation's Articles of Incorporation are amended to read "Number of Directors. The Corporation shall have no Directors. The primary shareholder shall manage the daily operations of the Corporation."

ARTICLE IV

The said amendment shall be adopted on the 22nd day of November, 1993 by the sole incorporator.

ARTICLE V

As of the 22nd day of November, 1993, no shares have been issued by High Desert Construction, Inc.

ARTICLE VI

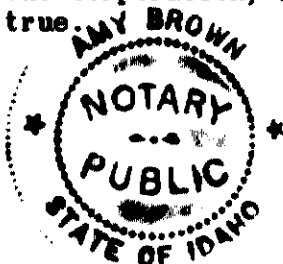


