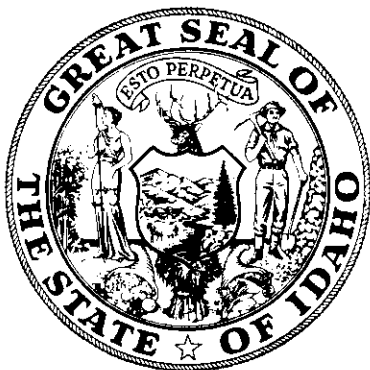

3. SHARES ISSUED. None


4. COMMENCEMENT OF BUSINESS. The Corporation has not commenced business.

7. ELECTION OF INCORPORATORS. The majority of the Incorporators elect that the Corporation shall be dissolved.


