The undersigned, acting as the Incorporator of a corporation under the PPOSSIONED, adopts the following Articles of Incorporation for such corporation:

I.

The name of the corporation is THE LEVIN PROFESSIONAL ASSOCIATION.

II.

The period of its duration is perpetual.

III.

The purpose for which the corporation is organized is the practice of medicine in accordance with the Idaho Professional Service Corporation Act.

IV.
