KNOW ALL MEN BY THESE PRESENTS: That the undersigned incorporators, all of whom are residents of the State of Idaho, and each and all citizens of the United States of America, of the age of majority, do hereby associate ourselves together to form and establish a corporation not for profit under the provisions of Chapter 10, Title 30, Idaho Code, and we do hereby certify and declare:

I

That the name of said corporation is and shall be Skyhawk Flying Club, Inc.

II

That said corporation is formed for the following purposes:

- (1) To acquire by purchase, lease or otherwise, and to sell, trade and dispose of aircraft, air navigation facilities and all related equipment incidental to the proper use and maintenance of aircraft.
- (2) To provide instruction and training in the art of navigation and aviation for the members of said corporation.
- (3) To do any and all such other acts, things, in any manner connected with or necessary, incidental, convenience or auxiliary to any of the objects herein before innumerated, or calculated, directly or indirectly, to promote the interest of the corporation.
- (4) The several clauses contained in this statement of purposes shall be construed as both purposes and powers, and the statements contained in each clause shall in ways limit or restrict, by reference to or inference from, the terms of any other clause, but shall be regarded as independent purposes and powers; and no

recitation, expression or declaration of specific or special powers or purposes herein innumerated shall be deemed to be exclusive; but it is hereby expressly declared that all other lawful powers not inconsistent herewith are hereby included.

III

The location and post office address of the registered office of the corporation shall be Twin Falls, County of Twin Falls, State of Idaho.

IV

That, subject to dissolution in the manner provided by law, the duration of this corporation shall be perpetual.

V

The rights and interests of all members shall be equal, and no member can have or acquire a greater interest therein than any other member. The corporation shall not issue any capital stock, but shall issue membership certificates to each member thereof, which certificates cannot be assigned so that the transferee thereof can be such transfer become a member of the association except by resolution of the board of directors and under such regulations as the By-Laws may prescribe.
