1 ARTICLES OF INCORPORATION OF SKYHAWK FLYING CLUB, INC.

3 KNOW ALL MEN BY THESE PRESENTS: That the undersigned  
4 incorporators, all of whom are residents of the State of Idaho,  
5 and each and all citizens of the United States of America, of the  
6 age of majority, do hereby associate ourselves together to form  
7 and establish a corporation not for profit under the provisions of  
8 Chapter 10, Title 30, Idaho Code, and we do hereby certify and  
9 declare:

11 I

12 That the name of said corporation is and shall be Skyhawk  
13 Flying Club, Inc.

14 II

15 That said corporation is formed for the following purposes:

16 (1) To acquire by purchase, lease or otherwise, and to sell,  
17 trade and dispose of aircraft, air navigation facilities and all  
18 related equipment incidental to the proper use and maintenance  
19 of aircraft.

21 (2) To provide instruction and training in the art of  
22 navigation and aviation for the members of said corporation.

23 (3) To do any and all such other acts, things, in any manner  
24 connected with or necessary, incidental, convenience or auxiliary  
25 to any of the objects herein before innumeraed, or calculated,  
26 directly or indirectly, to promote the interest of the corporation.

28 (4) The several clauses contained in this statement of  
29 purposes shall be construed as both purposes and powers, and the  
30 statements contained in each clause shall in ways limit or restrict,  
31 by reference to or inference from, the terms of any other clause,  
32 but shall be regarded as independent purposes and powers; and no

1 recitation, expression or declaration of specific or special  
2 powers or purposes herein inqumerated shall be deemed to be  
3 exclusive; but it is hereby expressly declared that all other  
4 lawful powers not inconsistent herewith are hereby included.

7 The location and post office address of the registered  
8 office of the corporation shall be Twin Falls, County of Twin  
9 Falls, State of Idaho.

10 IV

11 That, subject to dissolution in the manner provided by law,  
12 the duration of this corporation shall be perpetual.

13 V

14 The rights and interests of all members shall be equal,  
15 and no member can have or acquire a greater interest therein than  
16 any other member. The corporation shall not issue any capital  
17 stock, but shall issue membership certificates to each member  
18 thereof, which certificates cannot be assigned so that the trans-  
19 feree thereof can be such transfer become a member of the  
20 association except by resolution of the board of directors and  
21 under such regulations as the By-Laws may prescribe.
