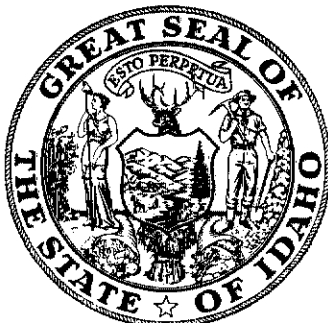

THE UNDERSIGNED, a natural person over the age of twenty-one (21) years, acting as incorporator of Silver Mountain Detail Supplies, Inc. under the Idaho Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

NAME

The name of this corporation is: Silver Mountain Detail Supplies, Inc.

ARTICLE II

DURATION

The duration of this corporation shall be perpetual.

ARTICLE III

PURPOSE

The purpose of this corporation shall not be limited and shall include all business purposes allowed by law.

ARTICLE IV

POWERS OF THE CORPORATION

This corporation shall have all of the powers granted or allowed by the Idaho Business Corporation Act, as may be amended from time to time, and all of the powers necessary or convenient to effect any or all of the purposes for which this corporation is organized.

ARTICLE VII

SHAREHOLDER RIGHTS

The shareholders of Silver Mountain Detail Supplies, Inc. shall have preemptive rights to acquire shares of Silver Mountain Detail Supplies, Inc.. The shareholders shall have the right to cumulate their shares when electing Directors of this corporation.

ARTICLE VIII

COMMENCING BUSINESS

This corporation shall not commence business until consideration of a value of at least \$1,000.00 has been received for the issuance of shares of Common Stock.

Common or interested Directors may be counted in determining the presence of a quorum at a meeting of the Board of Directors or committee thereof which authorizes, approves or ratifies such contract or transaction.

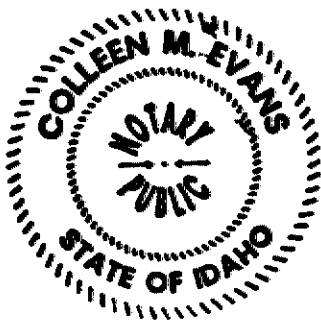


