ARTICLES OF INCORPORATION WELLATE

OF

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, in order to form a corporation, pursuant to the laws of the State of Idaho, do hereby certify as follows:

ARTICLE I

The name of this corporation shall be Community Memorial Services, Inc.

ARTICLE II

The period of existence and duration of the life of this corporation shall be perpetual.

ARTICLE III

This corporation is formed to carry out any lawful purpose and shall have all the powers allowed by the laws of the State of Idaho.

ARTICLE IV

The capital stock of this corporation shall be in the amount of \$100,000.00 divided into 100,000 shares of non-assessable common stock of the part value of \$1.00 per share.

ARTICLE V

The principal place of business of this corporation shall

be in the City of Boise, County of Ada, State of Idaho, at 2708 North 29th, which is hereby designated as the address of its registered office. Danny Gene Rohling is the registered agent, and lives at the above address.
