**ARTICLES OF INCORPORATION**

We the undersigned, residents of Bannock County and the State of Idaho have voluntarily associated ourselves together for the purpose of forming a non-profit organization under and by virtue of the laws of the State of Idaho and particularly under the provisions of the Idaho Nonprofit Corporation Act, Section 30-301 et seq., Idaho Code, and do hereby certify to the following:

1. The name of this nonprofit corporation is and shall be the Bannock Development Corporation.

2. That the Bannock Development Corporation shall function as a nonprofit corporation consistent with Idaho Law.

3. That the duration of this nonprofit corporation shall be perpetual.

4. That this nonprofit corporation is formed for the purpose of retention, recruitment and expansion of new and existing business and industry in the greater Bannock County area; to foster and promote better business relationships between and among business, industry and the Idaho university system; to enhance business relations and contacts with the Idaho National Engineering Laboratory and to promote a favorable climate for business and industry in the area. To achieve the stated goals and purposes, the nonprofit corporation may participate in all activities not prohibited by

law.

5. That the nonprofit corporation shall have classes of members as provided for in the bylaws.

6. That the management of affairs of the nonprofit corporation shall be vested in the Board of Directors as provided in the bylaws.


