I, ARNOLD WILLIAMS, Secretary of State of the State of Idaho, and legal custodian of the corporation records of the State of Idaho, do hereby certify that the original of the articles of incorporation of

GRANGEVILLE CHURCH OF THE NAZARENE, INC.

was filed in the office of the Secretary of State on the **Eleventh** day of **February** A. D. One Thousand Nine Hundred **Sixty-six** and **will be** **microfilm** **As** duly recorded on ~~XXXXXX~~ of Record of Domestic Corporations of the State of Idaho, and that the said articles contain the statement of facts required by Sections 30-103, 30-1101 and 30-1102, Idaho Code.

AND I FURTHER CERTIFY, That the persons executing the articles and their associates and successors are hereby constituted a corporation, by the name stated in the articles, and for **Fifty Year** from the date hereof, with its registered office in this State located at **Grangeville,** in the County of **Nez Perce,** and as such are subject to the rights, privileges and limitations granted to Religious, Ex-Service Men, Benevolent, Charitable and Fraternal Corporations, as provided in Chapter 11, Title 30, Idaho Code.

ARTICLES OF INCORPORATION OF THE GRANGEVILLE CHURCH
OF THE NAZARENE, INC.

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, have this day voluntarily associated ourselves together for the purpose of incorporating, under the laws of the State of Idaho, a religious corporation to be known as the GRANGEVILLE CHURCH OF THE NAZARENE, INC.

ARTICLE I The name of this corporation is GRANGEVILLE CHURCH OF THE NAZARENE, INC.

ARTICLE II The principal place of business of this corporation shall be in the County of Idaho, State of Idaho, at the Town of Grangeville, Idaho.

ARTICLE III That the term for which this corporation shall exist is FIFTY (50) years from and after the date of its original incorporation.

ARTICLE IV That the number of Trustees who shall have the management of the affairs of this corporation shall be five (5) and the names of the Trustees elected for the first year are: JOHN BAKER, DON CREA, W. H. FORTIN, LORN SKEEN, and RON HUTTER, all of whom are of full legal age, and at least two-thirds of whom are citizens of the United States of America.

That the said Trustees were duly elected at a meeting of the members of the said Church, which meeting was convened, upon notice by publication and posting as provided by the Idaho law, and held at North 2nd and "A" Streets, City of Grangeville, State of Idaho, on the 14th day of November, 1965, at 7:15 o'clock p.m. Said meeting was convened for the specific purpose of electing a Board of Trustees and carrying out the incorporation of the GRANGEVILLE CHURCH OF THE NAZARENE, INC., at Grangeville, Idaho, and all other business relating thereto. The majority of the

1 members of the said Church were present at such meeting and voted on the proposition
2 presented to the meeting all as is more particularly described and set forth in the
3 Certificate and Verification by the officers who conducted the election, which Certifi-
4 cate and Verification is hereto annexed and referred to and by such annexation and
5 reference made a part of these Articles as fully as though set out herein.

7 ARTICLE V The purposes and objects for which this corporation is formed are as
8 follows: To establish and maintain a Church in Grangeville, Idaho County, State of
9 Idaho, and to provide a place of worship thereat; to establish, maintain and conduct
10 schools for the religious instruction of the young, and of the members of the Church,
11 and to further other religious and charitable work, and to that end, to adopt and
12 establish bylaws, and make all rules and regulations deemed necessary and expedient
13 for the management of its affairs, in accordance with law, and not inconsistent with
14 these Articles of Incorporation, and according to the rules and discipline of the
15 INC.,
16 GRANGEVILLE CHURCH OF THE NAZARENE/ under the District Superintendent
17 and the Advisory Board of the Northwest District of the United States of America,
18 which said Church shall be subject to the privileges of the Government of the Church
19 of the Nazarene as the same is from time to time authorized and declared by the
20 General Assembly of the said Church; to purchase or otherwise acquire, hold, manage,
21 sell, mortgage or otherwise encumber or dispose of real or personal property of any
22 kind whatsoever; to receive hold and issue notes and bonds evidencing its indebtedness,
23 and to secure any indebtedness by pledge, mortgage or other encumbrance of its pro-
24 perty; to rent and lease real property, and to exercise all powers conferred upon it
25 by law, and all powers necessary or incidental to the powers expressly enumerated.

28 ARTICLE VI The Corporation shall have the power to make by-laws for the guidance
29 and control of trustees and other officers and agents of this Corporation in managing
30 its affairs, and thereafter the Trustees in power shall, at any time, have power to make

1 such additional prudential by-laws or amendments of any by-law for the guidance and
2 direction of the Trustees and other ~~other~~ officers and agents of this Corporation in the
3 transaction of its business affairs as may become necessary, convenient or advanta-
4 geous from time to time for carrying out the objects and purposes of the Corporation in
5 an orderly and businesslike way, and such additions or amendments to the by-laws
6 shall be made as provided in the by-laws to be done, provided, however, that the
7 said by-laws, made as aforesaid, shall not be repugnant to the laws of the State and
8 shall be consonant with the objects of the Corporation.

11 ARTICLE VII That the members of this Corporation shall be all the adult persons
12 who now are or who may hereafter become members of the GRANGEVILLE CHURCH
13 OF THE NAZARENE, INC., under the rules and dicipline of the said Church of the Nazarene
14 as embodied and set forth in the manual of said Church of the Nazarene, published by
15 the authority of the Sixth General Assembly thereof, in the year 1923, and any amend-
16 ments or additions thereto.


