ARTICLES OF INCORPORATION

We, the undersigned, natural persons of the age of 21 years or more, acting as incorporators of a corporation under the laws of the state of Idaho, adopt the following articles of incorporation for such corporation:

First: The name of the corporation is REMBRANDT ELECTRIC, LTD.

Second: The period of its duration is perpetual.

Third: The purpose or purposes for which the corporation is organized are to manufacture, produce, purchase, or otherwise acquire, sell, or otherwise dispose of, import, export, distribute, deal in and with, whether as principal or agent, goods, wares, merchandise, service, and materials of every kind and description related to electrical contracting, whether now known or hereafter to be discovered or invented, and all other acts authorized by law.

Fourth: The aggregate number of shares which the corporation shall have authority to issue is 1,000. The par value of each share is \$ .10.

Fifth: The corporation will not commence business until at least \$1 have been received by it as consideration for the issuance of shares.

Sixth: Cumulative voting of shares of stock is authorized.

Seventh: Provisions limiting or denying to shareholders the pre-emptive right to acquire additional or treasury shares of the corporation are none.

Eighth: Provisions for the regulation of internal affairs of the corporation are annual meetings.
