ARTICLES OF INCORPORATION

OF

SMITHMAN, SMITHMAN & TRAIL, INC.

KNOW ALL PERSONS BY THESE PRESENTS: That we, the undersigned, all full age citizens of the United States of America, have this day voluntarily associated ourselves together for the purpose of forming a corporation under and pursuant to the laws of the State of Idaho and we do hereby certify:

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is SMITHMAN, SMITHMAN & TRAIL, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are as follows:

- (a) General consulting and to transact any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.
- (b) To exercise generally the powers customarily exercised by business corporations, and particularly the powers provided by the laws of the State of Idaho, referring especially to Section 30-1-4, Idaho Code, in any state in the United States and throughout the world.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is five thousand (5,000) shares. These shares are to consist of one (1) class only and that class is common stock. The par value of such shares is fifty cents (\$0.50) per share, with an aggregate par value of two thousand five-hundred dollars (\$2,500.00). Such shares of stock shall be entitled to one (1) vote on all matters, and no preference or restrictions are granted to or imposed upon said shares of stock except that (a) such stock shall be non-assessable and (b) sale or transfer of such stock shall be restricted as set forth in the By-Laws of this corporation.

FIFTH: There are no provisions denying preemptive rights.

SIXTH: The address of the initial registered offices of the corporation is 1020 W. Franklin Street, Boise, Idaho, and the name of the initial registered agent at such address is J.E. SMITHMAN.

SEVENTH: The corporate powers of said corporations shall be vested in a Board of Directors, three (3) in number which shall be elected and chosen as set forth in the By-Laws of this corporation.
