

CERTIFICATE OF LIMITED PARTNERSHIP

The undersigned, constituting all of the General and Limited Partners of MERRILL HUBBARD AND SONS, LIMITED PARTNERSHIP, a limited partnership created under the laws of the State of Idaho, hereby acknowledge and execute this Certificate of Limited Partnership, pursuant to Idaho Code §53-208.

1. The name of the partnership is MERRILL HUBBARD AND SONS, LIMITED PARTNERSHIP.

2. The nature and purpose of the partnership's business is to engage in the business of farming and all other activities related thereto.

3. The principal place of business of the partnership is Star Route, Box 272, Grace, Idaho, 83241. The names and places of residence of the General and Limited Partners are as set forth below. The initial registered agent is Merrill D. Hubbard, whose address is Star Route, Box 272, Grace, Idaho, 83241.

4. The term of this partnership shall commence as of the date this Certificate is recorded and shall continue until terminated and dissolved as provided in the Partnership Agreement.

5. The initial contribution of the General and Limited Partners are as set forth opposite their signatures below. The Limited Partners have contributed no other property to the partnership.

6. The Limited Partners are not required to make any additional cash contributions.

7. There is no time agreed upon when the contribution of each Limited Partner is to be returned.

8. The share of profits which each Limited Partner shall receive of his initial cash contribution is as set forth opposite his signature below.

9. No Limited Partner may substitute as assignee of his/her place without the written consent of the general Partners. Any substituted contributor shall have all the rights that the original Limited Partner would have had.

10. No Limited Partner is entitled to priority over other Limited Partners as to contributions or as to compensation by way of income.

11. The retirement, withdrawal, death, insanity, incompetency, bankruptcy, or act of insolvency of any General Partner shall not dissolve the Partnership, if any remaining or successor General Partner elects to continue the business of the Partnership or if the remaining Limited Partners unanimously so elect in the absence of any remaining or successor General Partner.

12. The Limited Partners shall not have the right to receive property other than cash as return of their capital contributions.

13. A Limited Partner shall have the power to vote upon all matters described in the Idaho Limited Partnership Act.
