The undersigned incorporator, for the purpose of forming a corporation under the Idaho Business Corporation Act of the State of Idaho hereby certifies:

**First.** The name of the corporation is Impact Industries, Inc.

**Second.** The period of duration shall be perpetual.

**Third.** The purpose of the Corporation is to engage in any lawful act or activity for which a corporation may be organized under the Idaho Business Corporation Act, other than the banking business, the trust company business, or the practice of a profession permitted to be incorporated by the Idaho Professional Corporation Act.

Notwithstanding the foregoing sentence, a director shall be liable to the extent provided by applicable law, for breach of the director's duty of loyalty to the corporation or its stockholders, for acts or omissions not in good faith of law, or for any transaction from which the director derived an improper personal benefit. No amendment to or repeal of this Article shall apply to or have any effect on the liability or alleged liability of any director of the Corporation for or with respect to any acts or omissions of such director occurring prior too such amendment.

**Seventh.** The Board of Directors shall have the power to adopt, amend or repeal the by-laws of the Corporation.

**Eighth.** The number of directors of the Board of Directors shall be two. The directors of the initial Board of Director shall serve until either the first annual meeting of the
