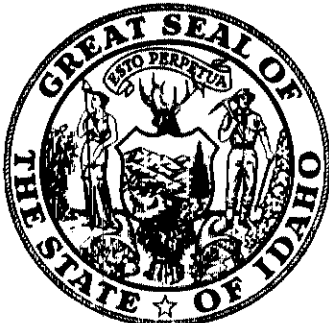
CERTIFICATE OF AMENDMENT OF

INCORPORATION OF JAMCO, INC.

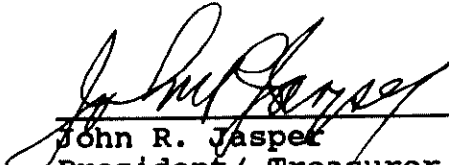

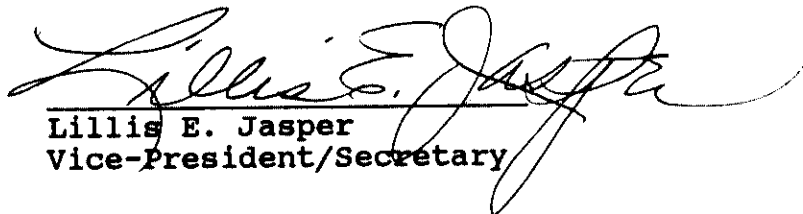
1. The name of the corporation is hereby changed to Valley View Subdivision, Inc.;

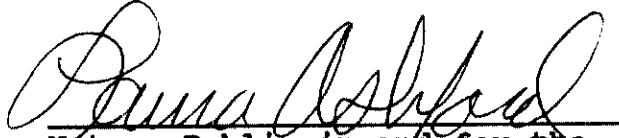

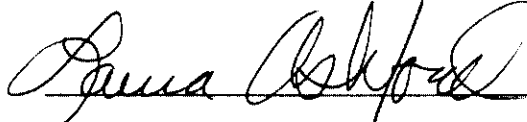

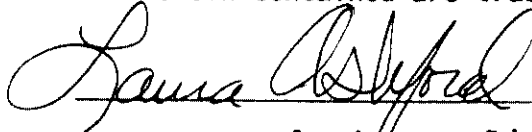
