## ARTICLES OF CMERGERTE

THESE ARTICLES OF MERGER are executed in duplicate by SAGE BRUSH TRUCKING CO., INC., and TRUCK SALES & LEASING CO., INC. — pursuant to <u>Idaho Code</u> §30-1-74.

- A. The Plan of Merger is as follows:
- 1. The parties agree to a merger as set forth in this agreement.
- 2. Each stockholder in Sage Brush Trucking Co., Inc., shall be issued one (1) share of stock in Truck Sales & Leasing Co., Inc., for each share of stock owned in Sage Brush Trucking Co., Inc.
- 3. Sage Brush Trucking Co., Inc., shall transfer all of its assets to Truck Sales & Leasing Co., Inc., subject to any indebtedness thereon.
- 4. Truck Sales & Leasing Co., Inc., agrees to assume any and all liabilities of Sage Brush Trucking Co., Inc.
- 5. Truck Sales & Leasing Co., Inc., shall continue to operate the existing businesses of Sage Brush Trucking Co., Inc., and Truck Sales & Leasing Co., Inc.
- 6. The remaining company after this merger shall continue to be known as Truck Sales & Leasing Co., Inc.
- 7. This Plan of Merger shall be effective upon its approval by the shareholders and directors of each of the parties hereto.
- B. As to Sage Brush Trucking Co., Inc., there were ten (10) shares of stock outstanding, none of which were entitled to vote as a class. As to Truck Sales & Leasing Co., Inc., there were ten (10) shares of stock outstanding, none of which were entitled to vote as a class.
