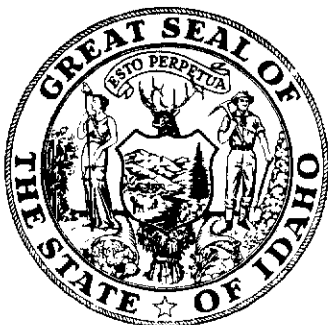

To the Secretary of State of Idaho


