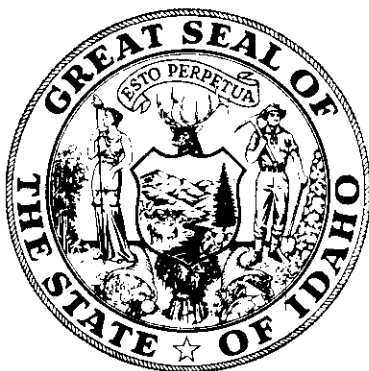

RESOLVED, Article I of the Articles of Incorporation of FOUR SEASONS A.R.A., INC. be, and the same hereby are, amended to read as follows:

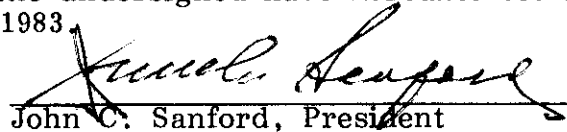
ARTICLE I

The name of this corporation shall be:

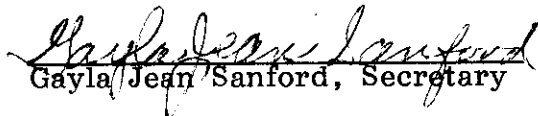
FOUR SEASONS DISTRIBUTORS, INC.

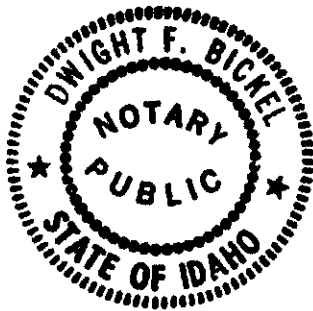
