ARTICLES OF INCORPORATION SECRETARY OF STATE

The undersigned, in order to form a corporation pursuant to the Idaho Business Corporation Act, certify as follows:

ARTICLE I

The name of the corporation is Ron Minegar Real Estate INC, (hereafter "Corporation").

ARTICLE II
