## ARTICLES OF INCORPORATION

## WILDERLAND, INC.

The undersigned hereby establishes a general business corporation pursuant to the Idaho Business Corporation Act and adopts the following charter:

- 1. The name of the corporation is Wilderland, Inc.
- The corporation shall commence on May 22, 1989, and the period of its duration is perpetual.
- 3. The purposes for which the corporation is organized include the transaction of any and all lawful business, including, but not limited to, real estate sales, development of real estate and reasonable related thereto.
- 4. The address of the initial registered office is 3965
  Star Valley, Boise, Idaho 83709. The name of its original registered agent at such address is Michael Crawford
- 5. The initial Board of Directors who are to serve as directors until the first annual meeting of shareholders or until their successors are elected and shall qualify are as follows:

- 6. The Board of Directors shall consist of two or more shareholders of the corporation as specified in its By-Laws, elected by the Shareholders of the corporation.
- 7. Each director shall hold office until the next annual meeting of the corporation or until his successor shall have been duly elected and qualified.
- 8. The officers of the corporation shall be a president, vice-president, secretary, and treasurer, and such other officers as the Board of directors shall designate from time to time.
- 9. The officers of the corporation shall be elected by the Roard of Directors and shall hold office until their successors shall have been duly elected and qualified.
- 10. The duties and powers of the officers shall be such as are normal and customary for their respective positions and as further designated and defined by the Board of Directors.
- 11. The aggregate number of shares which the corporation shall have authority to issue is 10,000 shares of common voting stock with no par value per share. The amounts of consideration received in exchange for the no par value stock will be determined by the Board of Directors.
- 12. Shares shall be voted only by the holder of record or another shareholder of the corporation in accordance with a written proxy executed by the holder of record.

- shareholder shall be either redeemed or canceled by the corporation, or transferred to another shareholder within six months after the date of death or retirement. Shares shall not be transferred to a nonshareholder without first being offered at their fair market value to the remaining shareholders of the corporation in proportion to their respective share holdings. Shares not so redeemed or transferred within the required period of time shall be canceled at the end of such period.
