

ARTICLES OF AMENDMENT to ARTICLES OF INCORPORATION



BLUE MOUNTAIN MINING COMPANY, INC.

The undersigned, being all of the shareholders of the corporation, hereby amend the Articles of Incorporation of Blue Mountain Mining Company, Inc., as hereinbelow set forth in these Articles of Amendment. Pursuant to Sections 30-1-59 and 30-1-145 of the Idaho Code, this Amendment was adopted by the unanimous vote consent of the shareholders of the corporation on the date hereinbelow stated. Said shareholders voted all of the outstanding shares of the corporation, said outstanding shares of the corporation being all of the shares entitled to vote thereon, said shares being a total of 800,000 shares, and said shares being common stock of the corporation.

FIRST

That Article Third of the Articles of the Corporation be, and the same hereby is, amended to read as follows:

The aggregate number of shares which the corporation has the authority to issue is Five Million (5,000,000) shares of common stock, all of one class, at a par value of \$1.00 each.
