I would like to make an amendment to the Church on the Rock's Articles of Incorporation. A meeting was held and the total of three (3) Board Members agreed upon the following changes to Article V - Distribution of Assets:, and Article VI - Tax exempt Status: # SEE Page 2

ARTICLE V - DISTRIBUTION OF ASSETS

"Upon the dissolution of this corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c) (3) of the Internal Revenue Code (or corresponding section of any future tax code), or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed by the Court of Common Pleas of the county in which the principal office f the corporation is them located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes."

ARTICLE VI - TAX EXEMPT STATUS

"Church of the Rock, Inc., of Boise is organized exclusively for religious spurposes within the meaning of section 501(c) (3) of the Internal Revenue ≅Code."

"Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a

Internal Revenue code of 1986 (or corresponding provision of any future United States Internal Revenue law)."

We have amended our Articles of Incorporation at the request of Randy Howard, Exempt Organizations Specialist, with the IRS in Monterey Park, CA. Please find enclosed the revised Articles.
