

ARTICLES OF INCORPORATION

WHEREAS, the Incorporators of Boise Senior Softball Association, (hereinafter referred to as the "Association"), located in Ada County, Idaho, provides for an Idaho Non-profit Corporation to administer certain common services and to perform other functions, and said Association is now being incorporated as a non-profit corporation:

NOW, THEREFORE, pursuant to the authority granted by the Title 30, Chapter 3, Idaho Code, the undersigned, who is a resident of Ada County, Idaho and is of full age, acting as incorporator, does hereby adopt these Articles of Incorporation and certifies to The Secretary of State as follows:

ARTICLE I

NAME & ADDRESS: The name of the corporation is BOISE SENIOR SOFTBALL ASSOCIATION, Inc. (hereinafter referred to as the "Association"). ARTICLE II

PURPOSE: The purpose of the Corporation is to promote men's senior softball in Ada County and to support activities, which will enhance the sport.

ARTICLE V

TERM: The term of existence of the Association is perpetual

ARTICLE VI

ORGANIZATION: This corporation is organized and operated exclusively for charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code. Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on, (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or the corresponding section of any future federal tax code or (b) by a corporation to which contributions are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE VII

MEMBERSHIP: The Association will have two classes of membership: The Board of Directors and the Regular Rostered Membership. Both classes of membership shall have voting rights.


ARTICLE VIII

PROPERTY: The property of this corporation is irrevocably dedicated to charitable purposes and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer or member thereof, or to the benefit of any private person.

ARTICLE IX

DISSOLUTION: Upon the dissolution, or winding up of the business of the corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation, shall be distributed to a non-profit fund, foundation or corporation which has established its tax exempt status under section 501(c)(3) of the Internal Revenue Code.

The undersigned, for the purpose of forming this non-profit corporation under the provisions of Title 30, Chapter 3, Idaho Code, constitutes the incorporator of this Non-Profit Corporation, and has duly executed these Articles of Incorporation on the 12th day of MARCH, 2003.
