1. The constituent entities in the merger (the "**Merger**") are BOISE RIVER CAPITAL, with its principal place of business at 5465 E. Terra Linda Way, Nampa, ID 83687, and LOCATE EXPRESS, with its principal place of business at 5465 E. Terra Linda Way, Nampa, ID 83687.
2. A Plan of Merger (the "**Merger Plan**") has been duly authorized and approved by the sole Shareholder and Director of LOCATE EXPRESS in accordance with Chapter 18, Part 2, Title 30 of the Idaho Entity Transactions Act (the "**IETA**"). The Merger Plan has been duly authorized and approved by the sole Member of BOISE RIVER CAPITAL in accordance with Chapter 18, Part 2, Title 30 of the IETA.
3. Pursuant to the Merger Plan and in accordance with the IETA, BOISE RIVER CAPITAL is being merged with and into LOCATE EXPRESS, with LOCATE EXPRESS being the surviving corporation in the Merger (the "**Surviving Corporation**").
4. The Merger is effective upon filing an executed version of this Statement of Merger with the Idaho Secretary of State pursuant to the IETA (the "**Effective Time**").
5. At the Effective Time, the Articles of Incorporation of LOCATE EXPRESS, as in effect immediately prior to the Effective Time, shall be amended and restated in


the form of the Amended and Restated Articles of Incorporation attached hereto as Exhibit A, and shall be the Articles of Incorporation of the Surviving Corporation.
