ARTICLES OF AMENDMENT

KNOW ALL MEN BY THESE PRESENTS: RECEIVED SEC. OF STATE

THAT WE, the undersigned, natural pansons of full age, guard of the United States of America, and being collectively a quorum of the members of THE JEROME METHODIST CHURCH, INC., have amended the original Articles of Incorporation dated May 26, 1947, and in support thereof submit the following Articles of Amendment:

I.

The name of the Corporation is THE JEROME METHODIST CHURCH, INC..

ARTICLE II.

The amendments so adopted are as follows:

Article I. of the original Articles of Incorporation is amended to read as follows:

The name of this corporation is THE JEROME UNITED METHODIST CHURCH, INC.

Article VII. of the original Articles of Incorporation is amended to read as follows:

The government of this corporation and the management of its affairs shall be vested in a Board of seven Directors, to be elected by the members of the corporation at the time or times and in the manner provided in the Discipline of the United Methodist Church. The Directors of the corporation shall be the Board of Directors of by-laws of this corporation.

ARTICLE III.

The amendments of the Articles of Incorporation were adopted by unanimous vote of the members at a magnified height 2 customatical cus

ARTICLE IV.

The total number of members of The Jerome Methodist Church, Inc. is 95. All members were entitled to vote on the adoption of the amendment.

ARTICLE V.

At the meeting of members held on Sunday , the 24th day of January , 1993, 6 members voted in favor of the amendment and 0 members voted against the same. At the meeting held on that date more than 50% of the members of the corporation was present thereby constituting a quorum.

ARTICLE VI.

The foregoing amendments affect a change in the name of the Corporation and changing the word "Trustees" to "Directors".
