

KNOW ALL MEN BY THESE PRESENTS that we, the undersigned, all bona fide residents of the City of Salmon, County of Lemhi, State of Idaho, have this day voluntarily associated ourselves, and do hereby and by these articles of association unite and associate ourselves for the purpose of forming a corporation under the laws of the State of Idaho:

First:- The name of this corporation shall be "SAWTOOTH and SALMON TOURING COMPANY."

Second: The period of the existance of this corporation shall be fifty years.

Third: The principal office and the principle business of said corporation shall be transacted at the City of Salmon, County of Lemhi, in the State of Idaho,

Fourth: The purpose for which this corporation is formed is as follows To furnish and to supply facilities for and to engage in the business of transportation of persons and property by Automobiles, over the main wagon roads in Blaine, Custer and Lemhi Counties in the State of Idaho, between the towns of Salmon City, Mackay, Challis and Ketchum; the town of Salmon being the northern terminal and the town of Ketchum being the southern terminal of the transportation line.

Fifth: The business and affairs of this corporation shall be managed by a board of five directors.

Sixth: The amount of the capital stock of this corporation is ten thousand dollars (\$10,000.00), divided into ten thousand shares of the par value of one dollar each.

Seventh: Of the said capital stock there has been actually subscribed Two Hundred Ten Dollars (\$210.00), by the following named persons and the amount subscribed by each, are as follows:
