FIRST: The name of the corporation is Garden City Chamber of Commerce, a non-profit organization.

SECOND: The pariod of its duration is perpetual.

THIRD: The purpose or purpose is for which the corporation is organized are:

- (a.) To a ertise Garden City and Idaho;
- (b). To se new industries 1 for Garden City;
- To Foster present industrie (c).
- To promote the holding of con (6) eventions and exhibitions in Garden City.
- (e). To promote transportation and further through Garden City;
 - (f), To acquire real and personal property by purchas. bequest, or otherwise, and to hold and convey real and personal property, and to hold title to real and personal property in trust;
 - (g). To do any and all things usually and customarily done by organizations of like kind.

FOURTH: That the place where the principal business of the corporation shall be transacted is the City of Garden City, County of Ada, State of Idaho. 1657 Chunden Block Harden City data 53704

RA. Bill Clarent powers of this corporation shall

be vested in a board of nine directors.

SIXTH: That the said Corporation is and shall be a membership corporation and corporations, associations and co-partnerships, as well as persons, may become members thereof.

There shall be two classes of memberships, via: Active and Non-active. Only members whose dues are paid are entitled to participate in the activities of the organization, provided, however, that each member in good standing, whether active or nonactive, shall be entitled to one vote in all meetings of the members. A member may vote in person or by proxy executed in writing by the member. No proxy shall be valid after eleven (11) months from the date of its execution. Each proxy shall be revocable at the pleasure of the member who executed it. Corporations, associations and co-partnership may delegate some individual to represent them at such meetings and on the membership roll.

SEVENTH: The number of directors consituting the initial
