CERTIFICATE OF INCORPORATION

I, ARNOLD WILLIAMS, Secretary of State of the State of Idaho, and legal custodian of the corporation records of the State of Idaho, do hereby certify that the original of the articles of incorporation of

BOISE VALLEY ROPING CLUB, INC.

was filed in the office of the Secretary of State on the **Nineteenth** day of **April**, A. D. One Thousand Nine Hundred **Sixty-three** and is duly recorded on Film No. **123** of Record of Domestic Corporations, of the State of Idaho, and that the said articles contain the statement of facts required by Section 30-103 and Sections 30-1001 to 30-1005, inclusive, Idaho Code.

I FURTHER CERTIFY, That the persons executing the articles and their associates and successors are hereby constituted a corporation, by the name hereinbefore stated, for

perpetual existence from the date hereof, with its registered office in this State located at

Boise in the County of **Ada**

and as such are subject to the rights, privileges and limitations granted to Non-Profit Cooperative Associations as provided in Chapter 10, Title 30, Idaho Code.

ARTICLES OF INCORPORATION
OF
BOISE VALLEY ROPING CLUB, INC.

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, all of whom are bona fide residents of the State of Idaho and of full age, have this day voluntarily associated ourselves together for the purpose of forming a corporation under and by virtue of Title 30, Chapter 10, Idaho Code, and do hereby certify, adopt, sign and acknowledge these Articles of Incorporation as follows:

ARTICLE I.

The name of this corporation shall be, "Boise Valley Roping Club, Inc."

Article II.

The corporate existence of this corporation shall be perpetual.

Article III.

The place where the principal business of this corporation shall be transacted is Boise, Ada County, Idaho, and the location and post office address of its registered office shall be Boise, Ada County, Idaho; meetings of directors may be held either within or without the State of Idaho.

Article IV.

The general officers of said corporation shall be three and the board of directors shall consist of at least two members, said officers and directors to be elected as hereinafter provided.

Article V.

The duties of the officers, in no way contrary to the laws of the State of Idaho, shall be fixed by the board of directors.

Article VI.

The officers shall be elected in such manner as may be directed by resolution of the Board of Directors and shall hold office for one year and until their successors have been elected and duly qualified. The Board of Directors shall be elected at the annual meeting of the membership in good standing and shall hold office for one year. A member who violates any of the ethics or rules of this club may be expelled from membership by a two-thirds vote of the Board of Directors present at a regular board meeting.

ARTICLE VII.

Subject to the provisions of the corporation laws of the State of Idaho, the directors shall have power to repeal and amend by-laws for the corporation. Subject to the provisions of the Statutes of Idaho, the corporation may, through appropriate by-law provisions, confer powers upon the Board of Directors in addition to the powers expressly conferred upon it by law and this Certificate.

ARTICLE VIII.

The general nature, purpose and objects for which the corporation is formed are:

- (1) To work for the betterment of conditions of roping and standards of roping contests.
- (2) To secure competent, honest judges and officials for roping shows and require that all entrance fees or participating ropers be added to prize money.
- (3) To bring about honest advertising by promoters or ropers so that the public may rely upon the truth of advertised events in which members of Boise Valley Roping Club participate or sponsor.
- (4) To publish information concerning the dates of roping shows, names, of contestants, prize money, and pertinent particulars concerning roping promoters and sponsors in which the public is interested.
- (5) To promote the highest and most ethical standards of policy on ropers.
- (6) To adopt and approve official rules for the members of the Boise Valley Roping Club.
- (7) To provide a uniform set of rules for contestants for the Boise Valley Roping Club, and directions of said club.

ARTICLE VIII.

This corporation is not organized for pecuniary profit and shall have no capital stock. The rights and interests of all members shall be equal and no member can acquire a greater interest therein than any other member.
