

DESIGNATION OF AGENT AND ACCEPTANCE OF THE PROVISIONS OF THE  
CONSTITUTION OF THE STATE OF IDAHO

KNOW ALL MEN BY THESE PRESENTS:

That W. P. FULLER PAINT COMPANY  
a Corporation organized and existing under the laws of the State of Delaware  
having filed in the office of the Secretary of State of the State of Idaho a duly authenticated copy of its  
Articles of Incorporation, does hereby, in pursuance of the laws of the State of Idaho, make this certifi-  
cate, and does hereby designate ADA County, in the State of Idaho, as the County in which the principal  
place of business of said Corporation in said State of Idaho shall be located, and does hereby designate

said ADA County, as authorized Agents of said Corporation in said State of Idaho, upon whom process

desiring and intending to conform in all respects to the Constitution and laws of said State, and to avail  
itself of the rights, privileges and immunities guaranteed by said Constitution and laws, does hereby  
accept the provisions of the Constitution of the State of Idaho for all the intents and purposes contem-  
plated by the provisions thereof, relating to such acceptance by other than municipal corporations.
