

Articles of Incorporation

of

Shoshone Electric Light & Power Company, Limited

Shoshone, Idaho

Know all Men by These Presents:

That we, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a corporation, under the laws of the State of Idaho.

And we hereby Certify:

FIRST. That the name of said Corporation is *Shoshone Electric Light and Power Company Limited*

SECOND. That the purposes for which it is formed are *constructing, procuring, operating and maintaining an electric light and telephone system in the Village of Shoshone State of Idaho, to generate, purchase, lease, or in any other manner procure power, electric or otherwise for the purpose of furnishing the inhabitants of the Village of Shoshone and adjacent territory with light and power, and for the purpose of furnishing light, electric or otherwise to individuals and corporations for manufacturing, domestic, commercial and other purposes, to borrow money upon bonds or otherwise secured by Trust, Deed, or Mortgage, or in any other manner for the purpose of generating, conducting, distributing and purchasing such electrical or other power for the purpose aforesaid. To buy and sell Real Estate and to manufacture, buy and sell all and any kind of electrical goods and supplies.*

THIRD. That the place where its principal business is to be transacted shall be

Shoshone, Idaho

FOURTH. That the term for which it is to exist is *Fifty* years from and after the date of its incorporation.

FIFTH. That the number of its Directors shall be *Five*, and that the names and residences of those who are appointed for the first year are:
