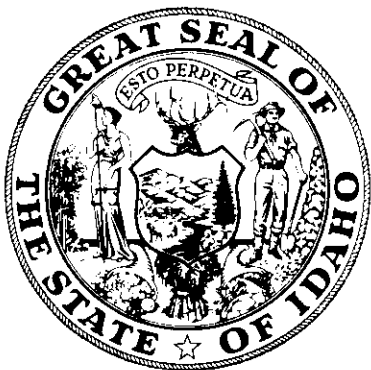

ARTICLES OF INCORPORATION  
OF  
IDAHO FUELS, INC. (I.F., INC)

The undersigned natural person(s) of full age, acting as incorporator(s) of a private corporation under the laws of the State of Idaho, hereby adopt Articles of Incorporation as follows:

ARTICLE I

The name of the corporation is Idaho Fuels, Inc. (I.F., Inc.)

ARTICLE II

The purpose(s) for which the corporation is organized are:  
The transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

ARTICLE III

The period of duration of the above corporation is perpetual.

ARTICLE IV

The aggregate number of shares which the corporation shall have authority to issue is 4,000,000 shares with a par value of \$1.00 (One Dollar) per share for a total authorized capital stock of \$4,000,000.00 (Four Million Dollars) all of which shall be nonassessable, common stock with equal voting rights and privileges.






