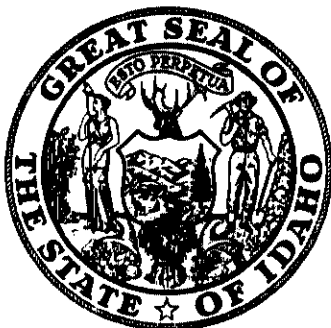
CERTIFICATE OF AMENDMENT OF

ARTICLES OF AMENDMENT

OF

COPYTECH PRINTING, INC.

Pursuant to the Business Corporation Act of Idaho, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of this corporation is:

COPYTECH PRINTING, INC.

SECOND: The following amendment of the Articles of Incorporation was adopted by the shareholders of the Corporation on March 17, 1993, in the manner prescribed by the Business Corporation Act of Idaho:
