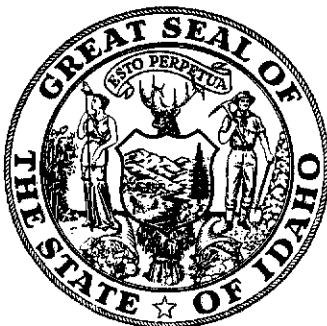

ARTICLES OF INCORPORATION

We, David A. Scott and Robert B. Van Wagoner, hereby incorporate the following corporation pursuant to the provisions of the Idaho Nonprofit Corporation Act. See Chapter 3, Title 30, of the Idaho Code.

I.
