

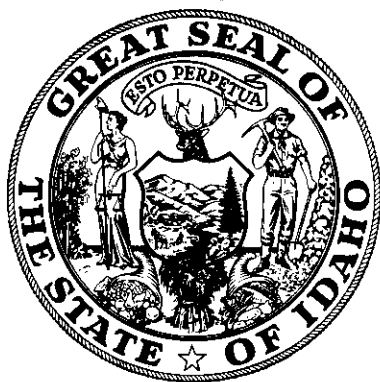
CERTIFICATE OF INCORPORATION

ARTICLES OF INCORPORATION

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is WILLIAMS FRUIT RANCH, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are: the transaction of any or all lawful business for which corporation may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is ten thousand (10,000) shares of common stock, with the par value of ten dollars (\$10.00) per share for a total capital authorization of one hundred thousand dollars (\$100,000.00). All of said stock shall be of one class and shall be common stock.

FIFTH: The address of the initial registered office of the corporation is 2455 South Slope Road, Emmett, Gem County, Idaho 83617, and the name of its initial registered agent at such address is HAROLD B. WILLIAMS.

SIXTH: The number of directors constituting the initial board of directors of the corporation is three, and the names and address of the persons who are to serve as directors until the first annual meeting of shareholders or until their successors are elected and shall qualify are:
