ARTICLES OF AMENDMENT OF ARTICLES OF INCORPORATION OF CLOVER TRINITY LUTHERAN CHURCH OF ROUTE 1, BUHL, IDAHO.

The undersigned, Vernon Lassen, Senior Member,

E. H. Gier and Wayne Schroeder, Members, are the Board of Trustees
of Clover Trinity Lutheran Church of Route 1, Buhl, Idaho, who
do hereby certify and declare as follows:

I.

That pursuant to the call of the Senior Member of the Board of Trustees of Clover Trinity Lutheran Church of Boute 1, Buhl, Idaho, made in accordance with its by-laws and the laws of the State of Idaho, a meeting of the members of said corporation was held on December 19, 1965, for the purpose of considering and acting upon the proposal to amend Article IV of said Articles of Incorporation by changing the term of the corporation's existence from fifty years from and after its incorporation to perpetual existence. That due notice of said meeting was given by publication in the Buhl Herald, a weekly newspaper regularly published in Buhl, Idaho, on November 26, December 2, December 9, and on December 16, all in 1965, and by posting a notice of such meeting in the church building and meeting place of said corporation where said meeting was held.

That at such meeting of said members, called and held as aforesaid and a quorum being in attendance, by unanimous vote of those members present, Articles IV of the Articles of Incorporation of Clover Trinity Lutheran Church of Route 1, Buhl, Idaho, was amended to read as follows, to-wit:

ARTICLE IV. That subject to dissolution in the manner provided by law, the duration of this corporation shall be perpetual.
