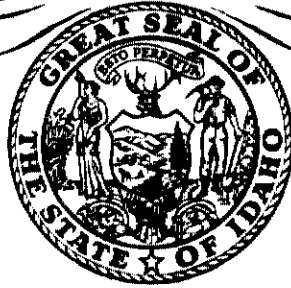

5 The undersigned, Vernon Lassen, Senior Member,
6 E. H. Gier and Wayne Schroeder, Members, are the Board of Trustees
7 of Clover Trinity Lutheran Church of Route 1, Buhl, Idaho, who
8 do hereby certify and declare as follows:

9 I.

10 That pursuant to the call of the Senior Member of the
11 Board of Trustees of Clover Trinity Lutheran Church of Route 1,
12 Buhl, Idaho, made in accordance with its by-laws and the laws of
13 the State of Idaho, a meeting of the members of said corporation
14 was held on December 19, 1965, for the purpose of considering
15 and acting upon the proposal to amend Article IV of said Articles
16 of Incorporation by changing the term of the corporation's
17 existence from fifty years from and after its incorporation to
18 perpetual existence. That due notice of said meeting was given
19 by publication in the Buhl Herald, a weekly newspaper regularly
20 published in Buhl, Idaho, on November 26, December 2, December 9,
21 and on December 16, all in 1965, and by posting a notice of such
22 meeting in the church building and meeting place of said
23 corporation where said meeting was held.

24 That at such meeting of said members, called and held
25 as aforesaid and a quorum being in attendance, by unanimous vote
26 of those members present, Articles IV of the Articles of
27 Incorporation of Clover Trinity Lutheran Church of Route 1, Buhl,
28 Idaho, was amended to read as follows, to-wit:

 ARTICLE IV. That subject to dissolution in the manner
provided by law, the duration of this corporation shall be
perpetual.
