# ARTICLES OF INCORPORATION

of

DRECHSEL BROS., INC.

We, the undersigned, being three or more natural persons of full age, at least two-thirds of whom are citizens of the United States or its territories or possessions, do hereby voluntarily associate ourselves for the purposes of forming a private corporation under the laws of the State of Idaho.

## I.

### NAME

The name of this corporation is DRECHSEL BROS., INC.

## II.

### PURPOSE

The purposes for which this corporation is formed and shall be conducted is as follows:

(a) To purchase farms and to carry on the business of farming, dairying, trucking and marketing and of producing, merchandising, manufacturing and preserving all kinds of farm, dairy, fruit, vegetable and garden products.

(b) To purchase and sell farms for commission or otherwise and to engage in the business of farming and of producing farm products of all kinds and nature and of cultivating, growing, harvesting, picking, cleaning, storing, packing, shipping, buying and selling all kinds of farm products and to carry on all business incident thereto and in connection therewith and to do a general commission of broker's business in any way relative to all the foregoing businesses.

(c) To conduct, carry on the business of buying, selling and dealing in all kinds of grain, hay or farm products, including livestock and all other kinds of goods, wares and merchandise connected therewith.

(d) To buy, sell, acquire, lease, rent all machinery, equipment of any kind or nature necessary or used in connection with the operation hereinbefore stated.

(e) To have, exercise, employ all those powers as granted by the provisions of 30-114 Idaho Code.

### III.

#### DURATION

The duration of this corporation shall be perpetual.

### IV.

#### LOCATION

The location and post office address of its registered office in this state shall be:

### V.

The total authorized number of par value shares is 7000 and their aggregate par value and the authorized number of shares of this corporation shall be \$700,000.00.

### VI.

All stock issued by this corporation shall be common stock having a par value of \$100.00 per share and all common stock issued shall have voting rights equal and commensurate each with the other. The total number of stockholders of said corporation shall be limited to ten (10) and no more.


