

ARTICLES OF INCORPORATION OF THE SWEETWATER IRRIGATING AND POWER COMPANY LIMITED.

Article , 1.

Name :- The undersigned desiring to avail themselves of the rights and privileges accorded under the laws of the State of Idaho, in reference to corporations; do hereby organize an incorporation to be known as the Sweetwater Irrigating and Power Company Limited.

Article , 11.

Purposes:- The purposes for which this corporation is formed is to engage in the business of constructing and operating water ditches and reservoirs. The principal ditch which said company has in contemplation is one to conduct water from the sweetwater creek, a stream located in Nez Perce County, State of Idaho, on to the adjacent agricultural lands in said County and State ; with such branch ditches and pipe lines for the conducting of water as the business of the company may require and with the right to acquire by purchase or otherwise the undivided stock and full title to water ditches and such real estate as may be necessary to carry out the objects of the organization; And with the right to dispose of the water from such ditches and reservoirs for irrigating and domestic purposes and for developing Mechanical power.

Article, 111.

Place of Business:-, The place where the principal business of said company will be transacted will be in the City of Lewiston, County of Nez Perce and State of Idaho.

Article, 1V.

Duration:-, The time for which said company is to exist is for the term of fifty years.

Article, V.

Directors:-, The business of this company is to be managed by a Board of five directors, those appointed to serve for the first year, with their places of residence is as follows; J. W. Poe, Lewiston, Idaho, John P. Vollmer, Lewiston, Idaho, A. W. Kroutinger Jr, Lewiston, Idaho, John W. Denny, Lewiston, Idaho,

Article, VI.

Stock:- The amount of capital stock of this company shall be fifteen thousand Dollars, divided into one hundred and fifty shares of the par value of one hundred ^{Dollars} each.
