ARTICLES OF INCORPORATION

The undersigned, acting as an incorporator of a corporation funder the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation is HIGH COUNTRY OF IDAHO, INC.

ARTICLE II

The period of its duration is perpetual.

ARTICLE III

The purpose for which the corporation is organised are the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

ARTICLE IV

The aggregate number of shares which the corporation shall have authority to issue is 100,000 shares. The shares shall be without par value. The shares shall not be divided into classes. There shall be no restrictions on the issuance of stock rights or stock options.

Each outstanding share shall be entitled to one vote and to the extent permitted by law, there shall be no right to vote cumulatively at the election for directors.

ARTICLE V

Sharehelders shall not have the preemptive rights to acquire any of the 100,000 authorised bur unissued shares of the corporation.

ARTICLE VI

Provisions for the regulation of the internal affairs of the corporation are as more fully set forth in the Bylaws.

ARTICLE VII

The address of the initial registered office of the corporation is 2404 Southside Blvd., Nampa, Idahe 83651 and the name of its initial registered agent at such address in Kenneth E. Redenius.

ARTICLE VIII
